

Description

EPC Space FSMD-A series of eGaN[®] power switching HEMTs have been specifically designed for critical applications in the high reliability or commercial satellite space environments. These devices have exceptionally high electron mobility and a low temperature coefficient resulting in very low $R_{DS(on)}$ values. The lateral structure of the die provides for very low gate charge (Q_G) and extremely fast switching times. These features enable faster power supply switching frequencies resulting in higher power densities, higher efficiencies and more compact packaging.








Figure 2. Typical Drain-Source Leakage Current vs. Ambient Temperature






Figure 4. Typical Output Characteristics at 25°C

Figure 3. Typical Gate-Source Leakage Current vs. Ambient Temperature






Figure 5. Typical Output Characteristics at 125 °C




Figure 10. Normalized On-State Resistance vs. Temperature




Figure 12. Typical Capacitance




Figure 9. Typical R_{DS(on)} vs. V_{GS} for Various Temperatures




Figure 11. Normalized Threshold Voltage vs. Temperature




Figure 13. Typical Output Charge and C_{OSS} Stored Energy




Figure 14. Typical Gate Charge




Figure 15. Safe Operating Area





Figure 16. Transient Thermal Impedance, Junction to Case





The G_S pulse drive ON time (t_{on}) is adjusted for the desired observability of the gate-source voltage (V_{GS}) waveform. The maximum duty cycle of the ground switch (t_{off}/t_{on}) should be set to 1% maximum. Please note that all gate-related signals are referenced to the "Source Sense" pin on the package. At all times during the measurement, the maximum gate-source voltage is clamped to 5 V_{DC} .
